## A Little History:

While browsing the new website archives, this writer came across a Special Edition of the *Silver Bulletin*, published in the Winter Quarter 2005. The edition highlighted the involvement of the TSHL at the fifth "White House Conference on Aging" (WHCoA) held in Washington, D.C., December 11-14, 2005. The article noted that, "White House Conferences on Aging have been held once a decade since the 1960s and have served as catalysts for the development and enhancement of national, state, and local aging policies in the United States."

As a result of the conference, the top 50 resolutions were identified and distilled into the following Top Ten Resolutions (sound familiar?):

- Reauthorize the Older Americans Act within the first 6 months following the conference
- Ensure that older Americans have transportation options to retain their mobility and independence
- Develop a coordinated, comprehensive long-term care strategy by supporting public and private initiatives that address financing, choice, quality, service delivery, and the paid and unpaid workforce
- Improve recognition, assessment, and treatment of mental illness and depression among Older Americans
- Attain adequate numbers of healthcare personnel in all professions who are skilled, culturally competent, and specialized in geriatrics
- Support geriatric education and training for all healthcare professions, paraprofessionals, health profession students, and direct care workers
- Promote innovative models of non-institutional long-term care
- Strengthen and improve Medicaid program for Seniors
- Strengthen and improve Medicare Program
- Improve State and local based integrated delivery systems to meet 21st Century needs of Seniors

While the delegates are not identified, the *Silver Bulletin* contains articles from then Speaker Chris Kyker, and SB editor and publisher, Ivan Arceneaux. The article notes that 1,200 delegates from across the nation participated in the conference.

The most recent WHCoA was hosted by President Barack Obama in July of 2015.

We are standing on the shoulders of some extraordinary Texans who have worked tirelessly as advocates for older Texans and the Texas Silver-Haired Legislature over the years. The next White House Conference on Aging will be in the year 2025! It's not too early to begin thinking about TSHL involvement in that important conference!
